

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.projectgood.work and Project Good Work and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Project Good Work include www.projectgood.work and PGW. The PGW website is a Information and Blog site. By using the PGW website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, PGW may collect personally identifiable information, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us.
